1 Safe Baby Court Sites With CASA vs. Without CASA


21 Safe Baby Court (SBC) sites were fully operational in 2024, and able to take referrals. These sites are Bradley, Coffee, Davidson, DeKalb, Dickson, Gibson, Grundy, Hamilton, Henry, Jefferson, Johnson, Johnson City, Knox, Madison, Maury, Perry, Robertson, Rutherford, Sevier, Stewart, and Sumner Counties. Johnson County ended operation June 30, 2024, and Cannon County was identified as the replacement site. Cannon County and Roane County began implementation in 2024, but did not start receiving referrals in 2024.

This report is a summary of Safe Baby Court program data collected by the AOC through the Quest case management system. The report shows data from each Safe Baby Court jurisdiction, as well as the Safe Baby Court outcome measures, for SBC cases with Court Appointed Special Advocates (CASA) and SBC cases without CASA. It is based upon information entered by the individual jurisdictions in the Quest case management system as of December 31, 2024, for SBC cases open for at least one day in since inception. Courts included in this analysis were Coffee, Davidson, Dickson, Grundy, Henry, Jefferson, Johnson, Madison, Maury, Rutherford, Stewart, and Sumner Counties. Courts with new SBC implementation in the second half of 2024 were excluded from the analysis.

As of December 31, 2024, there were **327 cases and 610 children** in SBC cases **with CASA** and **212 cases and 379 children** in SBC cases **without CASA**.

2 Length of Stay in SBC Intervention

2.1 Frequency Breakdown of Custodial vs. Non-Custodial Children


Custodial children, for the purpose of this report, are defined as children who spent at least one day in foster care.

SBC Status is defined at a case level; if any children in the case have an ongoing SBC, then each child attached to that case will have an SBC Status of "In Progress" in this section.


Note that the "Other" category can consist of instances such as a transfer of jurisdiction, a parent requesting to no longer be a part of SBC, a conflict of interest closing the case, or cases that were unsuccessfully discharged from the program by the judge or magistrate hearing the case.


2.3 Average Length of Stay in SBC Intervention

For cases with CASA, the average length of stay for custodial cases that successfully completed SBC was 542 days. The average length of stay for custodial cases in progress through December 31, 2024, is 621.8 days.

For cases without CASA, the average length of stay for custodial cases that successfully completed SBC was 468.1 days. The average length of stay for custodial cases in progress through December 31, 2024, is 411.6 days.

For cases with CASA, the average length of stay for non-custodial cases that successfully completed SBC was 352 days. The average length of stay for non-custodial cases in progress through December 31, 2024, is 374.4 days.

For cases without CASA, the average length of stay for non-custodial cases that successfully completed SBC was 283.1 days. The average length of stay for non-custodial cases in progress through December 31, 2024, is 224 days.

For custodial and non-custodial cases that were successfully completed, the following tables break down the average length of stay by permanency outcome.

3 Families and Children Participating in SBC

3.1 Type of Most Recent Living Arrangement

3.1.1 Number and percentage of children most recently in foster care placements and non-custodial placements

The following table shows the totals and percentages of last living arrangement for children in SBC. This represents the *current* placement or the *most recent* placement when the SBC case closed.

In cases with CASA, there were a total of **134 (22%) children most recently in foster care placements and 471 (77%) children in non-custodial placements**. Of children in foster care, 21 (16%) children resided with a relative.

In contrast, in cases without CASA, there were a total of 48 (13%) children most recently in foster care placements and 325 (86%) children in non-custodial placements. Of children in foster care, 19 (40%) children resided with a relative.

3.1.2 Number of placements throughout the SBC case

In cases with CASA, out of 605 children with identified foster care or non-custodial placements, **377 (62%) children were placed once**, 170 (28%) had two placements, 33 (5%) had three placements, 9 (1%) had four placements, 6 (1%) had five placements, and 7 (1%) had six placements, and 1 (0%) had seven placements during SBC.

In cases with CASA, out of 373 children with identified foster care or non-custodial placements, **279 (75%) children were placed once**, 75 (20%) had two placements, and 19 (5%) had three placements during SBC.

3.2 Length of Time in Foster Care

This section reflects the total amount of time that SBC children spent in foster care, rather than the amount of time that the children were in the SBC intervention.

3.2.1 Number of children in foster care less than 6 months, 7 - 12 months, 13 - 18 months, and 19 months or longer

In cases with CASA, 270 children were in foster care *at some point* during their SBC case. Out of those 270 children, 57 (21%) children were in foster care 0 - 6 months, 48 (18%) were in foster care 7 - 12 months, 66 (24%) were in foster care 13 - 18 months, and 99 (37%) were in foster care 19 months or longer.

In cases without CASA, 107 children were in foster care *at some point* during their SBC case. Out of those 107 children, 7 (7%) children were in foster care 0 - 6 months, 39 (36%) were in foster care 7 - 12 months, 27 (25%) were in foster care 13 - 18 months, and 34 (32%) were in foster care 19 months or longer.

3.3 Family Participation in Treatment Services

3.3.1 Number and percentage of families who participated in one or more services

In cases with CASA, a total of 327 families participated in SBC. Of these families, **289 (88%) participated in 3,262 services**. Of these services that were provided, 2,146 (66%) were successfully completed, 588 (18%) were not completed, 150 (5%) had a status listed as "Other", and 378 (12%) are in progress.

In cases without CASA, a total of 212 families participated in SBC. Of these families, **169 (80%) participated in 1,861 services**. Of these services that were provided, 1,321 (71%) were successfully completed, 402 (22%) were not completed, 18 (1%) had a status listed as "Other", and 120 (6%) are in progress.

The tables below show the 15 services most frequently provided to families with CASA and without CASA.

3.4 Visitation Plan Completion

3.4.1 Number of visits per case, averaged monthly

On average, families with CASA had 11.7 visits per month. Families without CASA had an average of 19.9 visits per month.
